

Thank you for your concern, kindness, love and support. The court case in question is actually very old.

I do want you to know however, that ThetaHealing nor I have ever been legally accused or taken to court over criminal fraud. ThetaHealing has never actually been on trial. This false info is called spin (misinformation.) However I have been sued for a contract dispute. I have also gone to court many times for trademark infringement 's (me fighting for our trade-mark) and a slander suit that I filed the suit was against people who were slandering ThetaHealing.

The case in question was a civil contract dispute that I had with one of my students. The question was brought up in court whether I had proof of a diagnosis of cancer. The question was not whether I had cancer and God healed it, they wanted me to prove the word diagnosis. Even though I presented documents, X-rays, and an expert witness the first stage of the case did not go well. I did not know it at the time that this was against my constitutional rights and first amendment rights. I did know that the courts were prejudiced towards me so I had to appeal it with the Idaho Supreme Court in which I went back and won almost 90% of the case.

If you see any summary of the case from the Idaho Supreme Court the first three pages do not read well and if you continue to read it you will find that I ended up winning it back. Even though I won 90% of the case, the Idaho Supreme Court ignored my constitutional rights, so I prepared it for a federal appeal with the United States Supreme Court.

In the Idaho Supreme Court findings you will also find a huge, undeniable prejudice towards me. This was because I was not involved in the communities basic religion. As you read it you will also observe that the Idaho Supreme Court chastised both attorneys for bringing this case to court in the first place.

But, I do want to thank you for your love and concern, but this was a long time ago and I know many of my older teachers loved and support me through this discriminating court case.

I have to admit, to this day I am still not used to people being so peculiar and attacking ThetaHealing. It is a shame to say but I know it's difficult for some people to believe that God heals so if you want to read more please finish reading the rest of the history of events.

A lot was going on in the year 2008. I was recovering from a coma, I started a school, so I could cover more classes and stay home a bit more. My son got a divorce and remarried a woman named Raena. That started a sequence of events where her ex-husband, ex-boyfriend his ex-wife all got together and started a campaign to discourage and disgrace ThetaHealing.

I have no idea how I became involved with this drama. All the EXs got together to make my life rather miserable and had it not been so strange, their viciousness would almost seem impossible, how did these three people get together?

Regardless, It came to a point that it was so bad that I actually ended up suing Josh's ex-wife and her friend (a student who was attempting to use ThetaHealing to extort business from all of our students) in civil court for slander. Then of course they appealed but the judgment held I thought it would stop the slander. But it just added fuel to the fire and they found a student who wanted to use a very common American legal system loophole to gain wealth by suing me. She had attempted to sue other healers as well. She brought a lawsuit of a contract breach, using the same attorney from the previous case.

In the year 2008 I created what was called a 'honorary Doctorate of Ministry in ThetaHealing' for my students, not a certificate, it was a plaque saying that they had completed all the courses I taught in theta healing.

I believe that this plaque expressed my love and honored their time and commitment. I let my class vote on the name they wanted to call it. They wanted a Doctorate of Ministry, a name used by reiki at one time. Doctorate of Ministry rather than the word master won the vote. one of my students was adamant at using this name. Little did I know, that she would come back and sue me.

At the end of 2008 Idaho put new requirements to register all schools as either proprietary or accredited for 2009 and forward. This was a new policy. It was at this time I made a decision whether to make ThetaHealing become an accredited course.

I decided not to make it accredited so that people did not have to get a student visa in order to attend a class. In doing so I would have to change the name of Doctorate of Ministry or make ThetaHealing a church. ThetaHealing is a philosophy not a religion. It is backed on faith and all religions are welcome. I decided to leave it as a proprietary school and change the name on the plaque. I was eager to comply with the new rules even though it was just a plaque.

It was never a Diploma or certificate it was at that time only a plaque saying honorary Doctorates of Ministry. ThetaHealing master plaques and certificate were formed. Since there was only a few that received the first plaque around 40-50 of my students had this change. Everyone was happy to comply and wanted the new plaque. It was another 2 or maybe 3 years before one of those students decide to sue over the plaque (unless I paid her money.) Yes, you guessed it, the woman who insisted on the doctorate name was saying I was giving false Doctorates. Mind you, she already took the new plaque and was using it to teach for almost three years after the change.

I had won the slander suit with the EX and her friend who had contacted this woman and told her to sue me, with their lawyer! So, I was sued for a contract dispute in which was brought up a question of whether I had been truly diagnosed with cancer. There is the funny part, it had been almost 20 years since I had cancer which by the way was way past the statute of limitations time .so I shouldn't even be able to be sued in the first place .the Doctor Who originally diagnosed me was dead, I didn't have his records but I had all the records from the University of Utah, which state exactly what is in my books that I wrote, *ThetaHealing* and in *On The Wings of Prayer*. I had the MRIs, I had the x-rays, I did not have the course of the treatment plan, because I never showed up. I kept these records, but any form of treatment records or recommendations were no longer available. what I did have was twenty-year-old records of all tests and though I kept those records for years. I had my journal and witnesses. What I didn't have was a good attorney.

Perhaps I should've went and got the lawyer more capable, perhaps the lawyer which I had from the first slander suit, but thinking it was just a simple contract dispute, I went to a contract lawyer, who had no idea how to handle this situation. First of all I thought that he was Baptist, knowing that many of the Mormons in the area are incredibly prejudiced against any intuition work, instead, I ended up with an Atheist he went to church for his mom, but he simply did not believe in God. He himself did not believe in healing, unlike my former attorney in the slander case did. I could feel my beliefs were a stretch for him. I thought it was a very simple procedure he took all the allegations went to the assigned judge who recognized that this had way too much to do with my constitutional rights. The original judge threw most of the everything out. However, knowing it might still come up as a question my attorney and I found an expert Oncologist from UCLA, since my University of Utah Doctor was no longer there after 20 years, to read the records... all of them.

He was an expert we discussed what happened to me, and he believed me when I told him they wanted to do chemo and radiation. It appears that treatment was used only that year so he believed me and the records. It seems instantaneous reemission of cancer is not that uncommon. He was excited to meet me and agreed to come up and testify for me in court after he gave me an interview and read my records, he would explain the diagnosis.

At this time most of the accusations, most of the case had been throw out. I had gathered people to court to prove that ThetaHealing worked. I had a group of people to testify of their healings Everything from MS to cerebral palsy, and cancer and how they had been healed.

I had this doctor from UCLA, I had my records I had, plus the record showing X rays, MRI, my heart failure records, that I had actually found in Italy about a coma I had them translated and I had my journal, my book, I thought I was prepared.

Just prior to starting court, however they changed the judges. The replacement judge was a retired judge, with an immense hatred for spiritualists, psychics, metaphysics, and all other religions. His reputation was horrible as most of his cases were appealed. Everything, everything, that was taken out he put back in. Because so much was against my civil rights to question my beliefs in God (which by the way is against the

constitution of the United States) and because it has already passed a certain amount of time. I truly had no idea of this, but I knew we might have some problems. I had by that time turned down a settlement, I knew if I settled it would never stop, and I would never deny God healed me.

Then it came time to pick my jury. Lots of people who showed up for jury call who were clients or clients friends and were eliminated for knowing me. As they picked the jury, I had a terrible feeling that this was not going to be so good.

The morning of the case Robbie the boyfriend, and co-plaintiff of the women suing me, did not show up. Still they went forward. I had a few ThetaHealing friends in court and my favorite doctor friend in court. Other healers that came from afar to testify. The accusations towards ThetaHealing were thrown out. All other accusations toward me left in. I was so alarmed that this simple civil court could be so Discriminating, they proceeded to tear me Apart, they attacked my belief that God healed me, but it came time for me to testify. I said that I believe God healed me the judge looked at me and told me that I could not say in court, that God healed me that was contempt and hearsay. I told him I could it was my right, he yelled at me if I said it again I would be in contempt of court. My attorney did nothing.

The opposing attorney told me to prove it, if I could call on god fill this cup up with water, so if I could connect with God to fill up the cup with water!!! It was incredibly strange it felt like a Salem Witch trial, perhaps on some level I have done this before. Innocent people were put to the death for made up lies. Perhaps, this triggered my DNA, as my ancestors were always had to fight for their beliefs in God. I tried to explain to the jury, what records I had without the original doctors records, with the records from the University of Utah which describe in detail the 9 inch tumor in my leg, the biopsy, the examination, what they believed it to be, exactly how it is written in my book, their diagnosis. Regardless, it fell on deaf ears. The jury simply didn't understand words like sarcoma are lymphoma. The testimony of the doctor from UCLA was totally disregarded, as he explained to them that it was a diagnosis. But the paper didn't say the word cancer it said sarcoma it said lymphoma(which is cancer all of these are cancer)because ThetaHealing had been dropped from the case they refused to see any of my witnesses of the proof of its validation. The witnesses, that I had picked to witness that I had a tumor and was healed with was; my neighbor, and a few

people that I knew at the time. I should've used my mother, but she had Parkinson's. I should've used my father, but he was far away I should've used my son, but he's already gone through so much trouble with his own problems with his divorce. I used my daughters. I should've used my best friend at the time, who had been there through all of this, she was going through a divorce at the time, and I didn't want to make her life more complicated. I didn't want to ask to pull them to testify unless I absolutely had to. When I did ask to call more witnesses I was told no. I called my daughters to share their experiences which were simply disregarded.

Their case?... they used the local cancer doctor in town, who never even looked at my records, admitted so in court, and said if I had had cancer I would be dead. The woman suing me testifying saying she believed that an honorary plaque that said Doctorate meant she would have a Doctor's degree.

I was in trouble and I considered the fact that I would probably lose this battle. My daughters humiliated, my husband in anguish unable to help me... so I consented. Concluding, I could appeal besides at that time the fine was about \$30,000. With my attorney not defending me, the judge led the jury and they gave me a huge fine, I felt alone.

Do you know how much courage you have to have to stand and say God healed you? In this critical world I've been abused traumatized a lot of my life. To step into the critical world was huge so I saved those test now over 20 years.

Lots of the healers showed up to testify I felt their love. ThetaHealing was never involved.

It was hard for me to believe that in America, we that have on our dollar the words in God we trust. That someone believing that God healed them, would ever come here to question, would ever be persecuted in this way. Although many go through so much more than me in the world persecuted and killed for their beliefs, I'm so fortunate to not have worse still I was devastated and disappointed I wished I had told more people what was going on and I tried very hard not to stress any one about me. Still ThetaHealing teachers came to my aid for comfort, for support. As the issues came up, my civil and constitutional rights were violated. At that time

I would go back to my office where, my other attorney was on the phone about a trademark problem, and I told her what happened.

I talked to my other attorney, that was my trademark attorney, and she had no idea this was happening in my life, after all it was just a simple contract dispute. Turns out she's a civil rights attorney and a very good one she told me we never should have gone to court and she immediately got with my attorney at the time using her expertise and filed for an appeal. She educated my attorney on what he did wrong. He didn't know what it took, then another couple years to get it taken care of we pushed it the appeal finally to the supreme court of Idaho that would rather have all of this embarrassing case disappear.

In the end the supreme court decision awards about 90% back to me. An actual victory for my attorneys, still I was so hurt it took hours of belief work to recover my dignity. The Idaho Supreme Court ruling speaks three pages of negativity about me actually chastising me for being a spiritual person and actually chastising both lawyers for ever letting this even get in court. Regardless, I wanted to take the 10% back to court, I sent my case to the Federal Supreme Court, "the Federal Supreme Court", so I could show them a violation of my rights and beliefs. It is very difficult to bring a case to the Federal Supreme Court. You have to have specialized attorneys and prove you have a case. Both of which I did. Michelle, my Attorney found a group of three Federal Supreme Court attorneys (you have to find special trained) to take my case. We applied to go to the Federal Supreme Court. They only pick a few cases every year to accept and they were excited to take my case. These specialist attorneys informed me that the Idaho Court's tried to add and use the words like fraud to hinder the growth of ThetaHealing and to stop me from sharing my religious experiences outside of their religious comfort zones. At this time there were only six people of the Federal Supreme Court judges they were looking for a seventh and they decided not to take any cases at this time, that had to do with any prejudiced or discrimination because of inability to not ensure and tied verdict.

I felt so discriminated against, but I decided to create a special attorney group for all healers so they are never attacked for believing in God and being treated with absolute dignity for their belief in God, at least that was my plan. I began to work on it immediately, I went to the Creator, who said do you really want to spend you entire life on this moment? This much of

your life fighting with this anger, which could change the world, or Change the world with love?

At first, I talked about the case a lot, even in my classes, I still bring it up, but it has been years now and I am focused on how we as a people can change the world. It is also important to note that the healing of my leg inspired me to see if it would work for others and it worked for others. I wanted to see if others could be taught the same thing, and they can be. ThetaHealing is based on the fact that other people can actually do the same things that I have witnessed. In point of fact, it has helped me grow in my love for other religions.

As for now, I am I already working with the best legal team that I have ever hoped for in my life to move forward with my beliefs.

What happened to me in Idaho happens to a lot of people in Idaho. They're discriminated for not being the same religion as the people around them. most of them cannot afford to appeal. What did I learn from this?:

- I have developed an amazing respect for other's beliefs, cultures and religions.
- I try to talk with more respect for others..
- I have more respect for my husband, family, and friends.
- I have an amazing trademark international trade market attorney civil rights attorney and a ThetaHealing instructor and friend that she's a wonderful soul
- I Listen for guidance
- I moved to where I was respected and loved ... Montana. Where all the people are very different religions and the constitution is still upheld. People actually respect, believe that God could heal. I love Montana it is a better state for me cherishes me and my family as we cherish it.
- I believe I'm kinder no longer a victim
- It's about honor
- I learned about my under current, my ego and my higher self.
- You can't make people accept your beliefs, if they do not
- I don't have to be a martyr
- I do not regret my decision to go to court, next time however I will make sure I take things way more seriously

- I always felt like things were left unsaid. I didn't want to bore my classes with my little adventure of stubbornness not settle out of court, people that were discriminated against me it was terrifying to have people that want to hurt you when you have been their friend their teacher. I will always remember the pain and how the creator healed me it no matter how many people ridicule and laugh at me, it doesn't change the fact that the Creator is real, you can tap into it I saved all the recordings of the court that they used to make the Manuscripts of if you want to know more about the trauma of the court you'll have to wait until when and if the movie comes out
